ORDINANCE 723-17

An Ordinance for Adding a Tactical Resource Fee and Emergency Clause.

WHEREAS, the City Commission of the City of Heavener, Oklahoma, pursuant to the powers delegated to it by the Oklahoma Constitution, State Law and City Charter, has the authority to enact laws that promote the public health, safety, and general welfare of its residents, and

BE IT ORDAINED BY THE CITY COMMISSION OF THE **CITY OF HEAVENER**

Tactical Resource Fee

Except as otherwise provided by state law, whenever in this code or in any ordinance of the town, an act is prohibited or is made or declared to be unlawful or an offense or a misdemeanor, or whenever in the code or ordinance the doing of any act is required or the failure to do any act is declared to be unlawful, the violation of any provision of this code or of any ordinance, upon conviction, shall be assessed, in addition to all other fines, penalties, and costs, a tactical resource fee of not exceeding One Hundred Dollars (\$100.00). Each day or a portion of a day, during which any violation of this code or of any ordinance shall continue shall constitute a separate offense.

ALL ORDINANCES AND PARTS OF ORDINANCES INCONSISTENT OR IN CONFLICT HEREIN ARE HEREBY REPEALED.

IT BEING IMMEDIATELY NECESSARY FOR THE PRESERVATION OF THE PUBLIC PEACE, HEALTH, AND SAFETY, AN EMERGENCY IS HEREBY DECLARED TO EXIST BY REASON WHEREOF THIS ORDINANCE SHALL TAKE EFFECT AND BE IN FULL FORCE FROM AND AFTER THE DATE OF ITS PASSAGE.
